### Terms and Conditions

1. A boat rack pass does NOT grant access to Jacobs Beach. A seasonal pass may be purchased for residents or a daily fee can be paid.
2. Racks must be rented from the Guilford Parks and Recreation Department on a seasonal basis.
3. All boats stored at Jacobs Beach must be kept in their assigned boat rack. **ONLY ONE** boat per rack.
4. Permits are non-transferable.
5. Boats are not permitted in the swimming area at Jacobs Beach.
6. All boats must be removed from the boat rack by **Sunday November 10th**. Failure to do so will result in a \$75.00 fine, for the 1<sup>st</sup> two weeks. A \$50 fine per month will follow until picked up.
7. The Guilford Parks & Recreation Department is not in any way liable for vandalism or damage done to your boat while it is stored at Jacobs Beach.
8. Boat racks are available on a first come, first serve basis. Requests cannot be honored.
9. Vehicles are not permitted on beach or grass area to transport boats. Vehicles must stay in the parking area and boats must be transported by hand to designated boat racks.
10. If a rented rack remains vacant for 30 days, the renter will forfeit the boat rack.
11. Any boat found in violation of any of the above regulations will be subject to immediate removal from the boat racks. Any cost associated with such removal will be at the owner's expense.
